## **INSTRUCTIONS FOR REQUESTING PAC FUNDS:**

- ⇒ PAC Contribution Request Forms must be fully completed to be considered by the PAC Committee.
- ⇒ All requests for PAC contributions must be directed to the PAC Committee Chair.
- ⇒ The PAC Committee Chair will forward all requests to the PAC Committee and the Executive Committee for review and discussion. In consultation with the Executive Committee, the PAC Committee will determine whether to make any requested contribution.
- ⇒ The PAC Committee Chair will advise the Executive Committee and the Government Affairs Committee of the PAC Committee's determination prior to making any contribution.
- ⇒ The PAC Committee Chair, Government Affairs Committee Chair and Executive Committee will together determine the most appropriate time, place and manner for delivering all PAC contributions to Candidates.

## **STANDARDS FOR MAKING CAMPAIGN CONTRIBUTIONS:**

In determining how PAC funds be distributed, the PAC Committee may consider, but may not limit their consideration to, the following factors:

- ⇒ The integrity and character of the Candidate for office.
- ⇒ Whether the Candidate for office holds a leadership or policy shaping position or is likely to hold such a position in the future.
- ⇒ The Candidate's positions and/or voting record on issues of concern to mortgage professionals
- ⇒ The nature and strength of the Candidate's campaign, including the Candidate's opponent(s) and whether the Candidate is running unopposed (FAMP PAC will not contribute to Candidates running unopposed).

## **MISSION & PURPOSE of FAMP PAC:**

- ⇒ To promote and work for the improvement of government by encouraging and stimulating responsible citizens to take an active part in governmental affairs.
- ⇒ To encourage responsible citizens' understanding of the nature and actions of their government as to important political issues and as to the records of office holders and candidates for elective office.
- ⇒ To assist mortgage professionals and others in organizing themselves for effective political action and in carrying out their civic and professional responsibilities.
- ⇒ To promote the economic growth of Florida and to raise funds for this purpose.
- ⇒ To encourage persons who, by their acts, have demonstrated their interest in the free enterprise system, to enter into political work without regard to party affiliation.
- ⇒ To do any and all things necessary or desirable for the attainment of the aforesaid purposes.
